**Cancellation Fee:** Should Client for any reason cancel or postpone, there will be a cancellation fee of \$25 for each date cancelled or postponed.

**Overtime:** Any time beyond the original time booked will cost \$80.00 per hour per entertainer. (Airbrushing is \$100.00 per hour per entertainer.)

**Parking:** The Client will reimburse the entertainer(s) for any parking fees and/or tolls.

**Travel Fee:** There will be an additional \$25.00 travel fee for destinations 50 minutes or more from zip code 08312 and every 50 minutes thereafter.

**Liability Statement:** Client warrants an understanding that Amazing Face Painting, LLC is disclaiming all liability from harm of any kind or nature caused directly or indirectly from the services rendered or products used. Client agrees that Amazing Face Painting, LLC's total liability, even for erroneous product content that causes damage to the client or guests of the client's event, shall be limited to the purchase price paid for the event. Client agrees Amazing Face Painting, LLC's total liability, for any other injury, harm, or tort of any kind, whether foreseeable or unforeseeable, shall be limited to the purchase price paid for the event.

Artist is not liable for bodily damage caused by glitter or allergic reactions to paints. It is the parent's responsibility to notify the artist if their child has sensitive skin. For sanitary reasons, artist will not paint anyone who is or appears to be sick or be suffering from: cold

sores; conjunctivitis; any infections skin condition; eczema or open wounds. Artist will use reasonable care, but is not responsible for damage to clothing or property. Stilt Walkers- All stilt walkers have the right to refuse entertainment based on harmful conditions. It is the responsibility of the client to ensure the safety of the entertainer by monitoring the crowd and environment surrounding the stilt walker (ex. unruly children, extension cords, etc..) Amazing Face Painting, LLC / All-Star Party Pros disclaims all liability from harm of any kind or nature caused directly or indirectly from stilt walking.

\*Please note that Amazing Face Painting, LLC takes many precautions to assure a safe and sanitary event. The brand paint we use manufactures its products using FDA compliant materials, packaging and processes that would provide FDA compliance (and their international counterparts). Amazing Face Painting, LLC's products are regulated as a cosmetic good and are just as safe (or more so) as something you would find at an upscale cosmetic counter. They do not use any materials in their products that could cause harm. Their factory and manufacturing procedures are also FDA compliant and have been inspected by appropriate federal staff. The products are also Hypoallergenic and were not tested on animals. Our cosmetic brushes and supplies are constantly disinfected to assure the highest level of sanitation. Our cosmetic paints also contain a natural anti-bacterial agent.
